Whatcom Community College Honors Program

What is the Honors Program?

Whatcom Community College has long been committed to excellence in education. The Honors Program has been developed to recognize academically talented students and to provide them with an opportunity to:

- Study aspects of a subject in more depth than a regular class allows
- Explore the interrelationship of knowledge
- Develop their talents and creativity
- Interact with other talented students
- Develop mentor relationships with faculty members

Both students and faculty benefit from the increased intellectual stimulation provided by the program.

How does the program work?

The program is designed to provide the Honors student with a variety of challenging learning opportunities:

One option consists of enrolling in honors seminars. These are two-credit courses linked to regular courses which fulfill core skills or distribution requirements in the AAS transfer degree. Students enrolled in a seminar will meet two hours per week with a faculty member and up to 12 Honors students to explore a topic in the subject area in depth. Four hours of work per week outside of class should also be expected.

As a second option, after the student has completed at least one Honors seminar, s/he may work with an approved faculty mentor to develop a special performance, exhibit, original research, or other product during the given quarter. These projects should exhibit knowledge at an advanced level.

A student must complete a minimum of two seminars/projects to graduate in the Honors Program.

What special services and privileges do students receive in the Honors Program?

Students in the Honors Program will be able to register the first day of registration. This will assure them access to the courses that are linked to the Honors seminars.

Honors students may select a faculty mentor in their major area of interest to help them with academic and career planning.

Students will graduate with Honors in the Honors Program provided that they maintain program requirements.

What is required once a student is accepted into the program?

To maintain active status in the Honors Program, a student must:

- Abide by the Whatcom Community College Students Rights and Responsibilities
- Maintain a 3.50 cumulative college-level GPA

How do I apply for the Honors Program?

A student may initiate an application at any time.

Students applying for the Honors Program should demonstrate superior academic ability and intellectual curiosity. A cumulative GPA of at least 3.50 is required. The process for acceptance into the program is:

- 1. Fill out an Honors Program application and return it to the Program Coordinator.
- 2. Attach an unofficial copy of your most recent transcript.
- 3. Submit at least one faculty or staff recommendation which addresses the student's creativity, intellectual curiosity, motivation, and commitment to go beyond the norm.
- 4. Demonstrate college-level writing in the Honors Program application and by placement in ENGL& 101.
