MINUTES BOARD OF TRUSTEES MEETING Laidlaw Center Board Room Wednesday, April 8, 2015 2:00 p.m.

◆ CALL TO ORDER Chair Tim Douglas officially called the Board of Trustees meeting to order at 2:02 p.m. Present in addition to the chair were trustees Barbara Rofkar, Chuck Robinson and Steve Adelstein, constituting a quorum. Sue Cole was absent. Others present included President Kathi Hiyane-Brown; Ron Leatherbarrow, Vice President for Instruction; John Baker, Interim Vice President for Student Services; Ed Harri, Dean for Instruction; Melissa Nelson, Assistant Attorney General; and Rafeeka Kloke, Executive Assistant to the President.

ACTION TO ACCEPT AGENDA

PRESIDENT'S REPORT

- Three WCC nursing students received scholarships from Washington State Nurses Foundation (WSNF) in the amount of \$1,000 each.
- → Sukhdip Singh and Marco Morales, two WCC students, were honored at last month's All Washington Academic Team Recognition Ceremony. They were each presented with a \$500 scholarship. Sukhdip Singh was presented with an additional \$1,000 scholarship for his academic achievements.
- → A number of WCC staff have been invited to present at regional and national conferences, including Ward Naf, Director for Information Technology; Dave Knapp, Associate Director for Advising & Career Services; Christine Choi, Student Completion Coach; Tawny Townsend, Director for Student Access First Year Experience; and Keri Holferty, Associate Director for Access & Disability Services.
- President Kathi received a note from Lonnie Howard, president of Clover Park Technical College, thanking John Baker and Kathy Barnes for sharing best practices in Outreach, Admissions, and Advising.
- ◆ A team, led by John Baker, is working with BTC on a Title III grant from the US Department of Education.
- → The College recently secured a lease with Baker Creek Apartments for additional apartment units to accommodate the growing demands from our International Program . An update on student housing will be provided to the Board at the upcoming board retreat.
- → The FTE enrollment for spring quarter is down 1.5% compared to this time last year. Drop for non-payment numbers were down spring quarter compared to last year. There has been an increase in International, Running Start, and online enrollment.

- Four VP for Student Services finalists will be invited to campus for interviews mid-April.
- President Kathi is participating in two panel presentations at Asian Pacific Americans in Higher Education (APAHE) annual conference and three panel presentations at American Association of Community College (AACC) annual conference. Topics include college culture and organizational culture for new presidents; recruiting, hiring and retaining diverse leaders; advance technologic education centers; and diversity and inclusion.

The Curriculum Committee has recommended approval of the proposed degree, "Business Direct Transfer Agreement / Major Related Program (DTA/MRP)-Associate in Business." Requirements for completion of the degree are specified in the attached document. The requirements conform to the DTA/MRP agreement between the State Board for Community and Technical Colleges and the participating public and independent baccalaureate institutions. This addition to WCC's degree offerings will increase options and provide a structured transfer pathway for students seeking further study in business. The degree requires no additional coursework to be developed in order to implement the degree.

Approval of this degree allows students to immediately begin their pursuit of the business transfer degree recognized and accepted by public institutions in Washington State.

The Associate in Business(DTA/MRP) degree is a statewide articulated 90 credit transfer degree agreement for business majors between the community colleges and most four-year institutions. Students will enter the four-year institution's business department at the Junior level. However, admission is not guaranteed. To earn this degree, students must complete a minimum of 90 credits numbered 100 or above as specified in the degree, and earn a minimum of 2.0 grade point average.

Associate in Nursing Degree

Whatcom's Curriculum Committee has recommended approval of the proposed degree, "Nursing Direct Transfer Agreement / Major Related Program (DTA/MRP)-Associate in Nursing." Requirements for completion of the degree are specified in the attached document. The requirements conform to the Direct Transfer Agreement template recently approved by the Board of Trustees and specified by the State Board for Community and Technical Colleges and participating baccalaureate universities. This degree will be one of the first transfer degrees in alignment with current initiatives in Washington State and nationally, and this degree facilitates the transfer agreement with nursing programs at the public universities in Washington State.

This degree will educate students to practice professional nursing within varied health care settings in collaboration with other members of the health care team and to assist individuals who experience health care problems to progress toward optimal health and wellness. The program also prepares students to take the National Council Licensure Examination for Registered Nurses (NCLEX-RN). The DTA program changes do not reduce student preparation for a nursing career that our current degree program offers, but instead provides students with the option for a more seamless and efficient transfer process to pursue a bachelor of science in nursing degree.

Approval of this degree allows Whatcom Community College to become one of the first colleges in Washington State to offer this pathway, beginning in fall quarter 2015.

♦ ASWCC− Fahren Mansour, President

- The ASWCC S&A Budget Committee finalized allocations for the 2015-16 fiscal year and presented the budget proposal to the Student Senate.
- We have been recruiting heavily and are currently going through our annual hiring
 process to select next year's student leaders. We received 60 applications for the 23
 leadership positions within the ASWCC. The candidate pool is very strong and we are
 excited for next year's team. We're filing positions for the Executive Board,
 Programming and Diversity Board, and Student Ambassadors. Candidates will go
 through a series of group and individual interviews. We hope to have our team selected
 by June 5th.
- The ASWCC has been preparing for the Ski to Sea and will represent Whatcom in the parade.
- Sukhdip Singh has been working with BTC to support their May 21st Turban Awareness Day.
- Two members of the ASWCC Social Justice, Equity, and Pluralism Committee presented a workshop on Stereotypes. Another workshop on Power and Privilege is scheduled for this quarter.
- We received 21 workshop proposals for the second annual Student Leading Change Conference, which will be held May 30th. We've received good support from the community and have students coming from as far away as Olympic College.

WCCFT—Tresha Dutton, President

- The faculty and administrative teams continue to meet weekly to discuss contract negotiations. Much progress has been made, although the State's inability to finalize a budget is hindering some discussions.
- The faculty eagerly await the upcoming Vice President for Instruction campus interviews, and appreciate the opportunity to talk with each candidate individually in the faculty forum part of their campus visits.

Administrative Services—Nate Langstraat, Vice President

- **Finance** (Goal 5.1 Create and manage growth through fiscal, capital, technological and human resource development)
 - The financial statement and accountability audits by the State Auditor's Office are nearly completed. The state audit team spent nearly 7 weeks on-site, gathering data and meeting with Whatcom staff. An exit meeting is anticipated to take place by mid-May.

- The Business Office staff is preparing for year end. The current year procurement deadline has passed, and all non-essential purchasing must wait until the new fiscal year.
- Budget development for 2015-16 continues. Budget managers have submitted their requests, and the Budget Development Team is working with college leadership to continue gathering the data necessary to produce the 2015-16 budget.
- Facilities & Operations (5.1: Create and manage growth through fiscal, capital, technological and human resource development)
 - Construction documents preparation for the Phyllis and Charles Self Learning Commons continues and will be completed in July. The project has not been funded for construction in the 15-17 biennium, although at this point the final capital budget has yet to be signed. The State Board will consider funding strategies for the building (and other unfunded SBCTC projects) at their June meeting.
 - The Pavilion and Student Recreation Center continues to progress. Site work has begun. The brick exterior is complete and curtain wall is ongoing. Our selected artist, Susan Zoccola, visited the construction site on March 24 to view progress and coordinate the art installation schedule.
 - o Planning is underway for projects that will be funded in the 2015-17 biennium.
 - Capital project updates and information is now located on the WCC public website at www.whatcom.ctc.edu/news.
- **Emergency Preparedness & Safety** (5.3. Promote a safe environment for teaching, learning, and working)
 - New reporting channels are now available between Whatcom and the Department of Homeland Security. Jonah Stinson has been vetted as a Liaison Officer with the Washington State Fusion Center, which allows for direct communication and information exchange on situations or persons of concern.
 - Whatcom recently participated in the County's regional exercise for Community Points of Distribution. The campus has executed pre-planning and agreements for staging resources in a regional emergency or disaster.
 - o Safety planning continues for June's commencement ceremony at Civic Field.
 - Position-specific Incident Command training courses have been developed for Whatcom's Emergency Response Team. Ideas are currently being discussed for a series of collaborative training sessions with participation from both WCC and BTC staff.
- **Conference & Event Services** (3.1 Increase College Stature as a community and educational partner)
 - Internally, Conference & Event Services (CES) is supporting the Diversity in Education Conference on May 15. This is a joint conference with WWU and Skagit Valley College's Centers for Excellence in Education with co-sponsorship from WCC's Prof Tech division. CES and the Commencement Committee have also been meeting and working on the planning for the 2015 Commencement Ceremony. The main vendors have been contracted; all timelines are ahead of schedule.
 - Externally, CES will provide support for the Lummi HS Prom and Bellingham
 Public Library's Bellingham Anime Conference. Orca Field welcomes back

- Bellingham United Football Club practices and will also be the location for a Vancouver Whitecap youth tournament. The now rentable grass practice field has also seen an increase in usage.
- **Bookstore** (Goal 5.1 Create and manage growth through fiscal, capital, technological and human resource development)
 - o In the 2014-15 academic year, students have saved over \$270,000 (vs. purchase price) via the Bookstore's textbook rental program. Compared to last year's totals, the Bookstore has already increased the number of titles offered and rented, the number of individual and unique students renting books, the dollar value of rented books, and overall dollar savings for students

Student Services—John Baker, Interim Vice President

- Athletics (Goal 1.1 Increase student achievement in transfer and career preparation)
 - Winter quarter grades for student athletes is a combined total of 2.98 with the volleyball team leading the pack with a team gpa of 3.45.
- Entry and Advising (Goal 1.2 Increase academic support for students, Goal 1.3 Increase access for diverse and nontraditional student populations)
 - Advisor for Transitional Programs visited 5 ABE classes to help students transition to college courses or programs. Presentation begins with an introduction of services and an explanation of different educational and career pathways available at WCC and ends with a discussion with individual students for more specific "next steps."
- Outreach (Goal 1.2 Increase academic support for students, Goal 1.4 Introduce new opportunities for student learning and engagement)
 - O AmeriCorps' College Access Corps (CAC) program recently approved Outreach Services' application for a CAC volunteer, beginning August 2015. The CAC volunteer, a full-time 10-month position, will be primarily responsible for recruiting, training, and mentoring WCC students serving as "College Access Coaches" to lowincome students attending Whatcom County high schools. College Access Coaches will spend at least 15 hours with high school students, assisting with college access preparation – success strategies, admissions applications, financial aid options, and more. The program also includes a visit to Whatcom's campus

- **Hiring** (2.1 Maintain currency in college curriculum and delivery, 2.3 Improve student learning, and 5.1 Create and manage growth through fiscal, capital, technological and human resource development)
 - o **Faculty**: Searches for 3 faculty positions are progressing. The search for a visual communications instructor is now completed; an offer has been made and accepted. The search in chemistry is in its final stages. Interviews are currently being scheduled for the vice president and dean to meet with finalists for the psychology position. The math faculty position application process closed on May 4, and the committee will soon meet and select applicants for interviews. The application process for the counselor position will close on May 15.
- New BAS Degree (1.1 Increase student achievement in transfer and career preparation; 3.3 Be an active partner in economic development).

- The BAS in IT Networking was approved by the SBCTC on Thursday, May 7. CIS faculty will now proceed with submitting all course work to WCC's Curriculum Committee for approvals; the College may proceed with enrolling students in the new program once the substantive change proposal is approved by the NWCCU (anticipated June 2015) and the courses are launched.
- HEET Grant Renewal (1.1 Increase student achievement in transfer and career preparation; 3.1 Increase College stature as a community and educational partner; 3.2. Lead collaborative efforts with other educational institutions; 3.3 Be an active partner in economic development; 5.2 Diversity and secure funding/resources from external sources).
 - O WCC submitted a proposal to extend the Hospital Education & Training (HEET) project. The North-South Care Coordination Consortium is a partnership between community colleges (Whatcom, Edmonds, Highline, Yakima, Clark and Seattle Central), SEIU Healthcare 1199 NW Multi-Employer Training & Education Fund, Workforce Development Councils, SEIU Healthcare 1199 NW, and industry. Funds of \$579,775 requested for 2015-16 will allow colleges to build off of strong successes this year. WCC is the lead institution; by working with new partners (Washington Dental Service Foundation and the Allied Health Education Center) the project will:
 - offer a refined care coordination/patient navigation certificate training program, which will be further enhanced by infusing oral health curriculum into the courses;
 - develop additional behavioral health and aging populations courses;
 - expand partnerships between the participating colleges and hospital labor/management in Washington.
- **Girls Go Tech** (1.3 Increase access for diverse and nontraditional student populations; 3.1 Increase College stature as a community and educational partner).
 - o The seventh installment (sixth year) of Girls Go Tech was held on Saturday, April 25, with 23 girls in attendance, each accompanied by a parent or guardian. Students enjoyed hands-on activities in physics and CIS/cybersecurity labs. They learned about electrical circuits Raspberry Pi computer projects and cybersecurity vulnerabilities. A highlight of the event was guest speaker retired Navy Captain and NASA astronaut Wendy Lawrence. Funding was provided by a Perkins Non-Trad grant with additional support from local service organizations and businesses.
- **Faculty professional development workshops** (2.5 Increase professional development opportunities for faculty and staff; 4.1 Reinforce diversity efforts in curriculum).
 - o Betsy Hasegawa, director for intercultural affairs and leadership, facilitated the final faculty professional development workshop for 2014-15, titled *Teaching in a Changing World*. Approximately 25 faculty participated in the workshop, during which time they completed readings and had discussion groups about identity, privilege, and interculturalism. Participants have already formed professional learning communities to continue the efforts started in the workshop.
- Volunteer Income Tax Assistance (VITA) (1.1 Increase student achievement in transfer and career preparation; 1.4. Introduce new opportunities for student learning and engagement; 3.1 Increase College stature as a community and educational partner)
 - For the fourth consecutive year, Whatcom's accounting program students
 participated in the VITA Program, providing free assistance with tax preparation.
 Accounting program coordinator John Fasler (an enrolled fiscal agent) reviewed all

tax returns prepared by students and was on hand to address complex issues. VITA was open to the public on weekdays, February 9 through April 13. Tax returns were prepared for 113 clients, up from 86 returns the prior year. A total of 25 Whatcom students contributed their time and talents to the program. Student participation requires a commitment of at least three hours per week for the duration of the program. Training on basic tax law and the preparation of individual tax returns is provided and students are required to pass the VITA certification exam. The VITA program is sponsored by the IRS and, in Whatcom County, by WWU's Beta Alpha Psi and Accounting Society and the WCC Business Club.
