- CALL TO ORDER Chair John Pedlow officially called the Board of Trustees meeting to order at 2:06 p.m. Present in addition to the chair were trustees Steve Adelstein, Wendy Bohlke, Rebecca Johnson, and Teresa Taylor constituting a quorum. Others present included President Kathi Hiyane-Brown; Ed Harri, Vice President for Instruction; Nate Langstraat, Vice President for Administrative Services; Luca Lewis, Vice President for Student Services; Sue Cole, Executive Director for Advancement; Kerena Higgins, Assistant Attorney General; and Rafeeka Kloke, Special Assistant to the President.
- Chair Pedlow welcome Kerena Higgins, Assistant Attorney General, newly assigned to Whatcom Community College.

STRATEGIC CONVERSATION

✤ Title III Project Overview – Michelle Mcllvoy, Title III Project Director

Eric Harri, Vice President for Instruction, introduced Michelle Mcllvoy. Harri shared that the grant proposal submitted April 2017 was awarded in September 2018 for a total of \$2.25 million (\$450,000/year) for 5 years.

Mcllvoy shared a PowerPoint presentation with an overview of the grant and activity components. The three main components included:

- Teaching and Learning Center Designed to guide, immerse, and support faculty from day one in high-impact, evidence based strategies to transform the classroom experience
- Welcome Center Designed to transform the entry and progression experience and guide students along a pathway to success
- Guided Pathways Training Designed to provide faculty and staff comprehensive and intentional training in Guided Pathways implementation

She shared that a significant amount of work had been completed around guided pathways at Whatcom, with the new infusion of funding through this grant; the work can now be expanded to a larger scale.

Engineering Program Update – Eric Davishahl, Faculty

Ed Harri, Vice President for Instruction, introduced Eric Davishahl, Engineering faculty. Davishahal shared a PowerPoint presentation with an update on WCC Engineering Program.

Highlights included:

- Whatcom serves a diverse array of transfer goals with engineering majors in a number of disciplines
- Graduates with Engineering Associate in Science-Transfer degrees are ready to transfer to nearly every engineering BS program in WA and beyond
- Enrollment in the program is increasing with 43 FTEs in 2017-2018
- Active student clubs on campus including: Engineering Club, AWSEM (Advocates for Women in Science Engineering and Math) and Rocketry and Propulsion Society
- Outreach with focus on getting youth interested in STEM
- Grants received included: 2 grants from Alcoa Foundation for equipment and Aerospace FTEs allocation from the state

In addition, the College is again ranked 3rd in the state in receiving National Science Foundation grant funds, the only two year college in the top three behind Washington State University and University of Washington. The College will continue to be vigilant in seeking grant opportunities.
- Janice Walker, Dean for Workforce Education and Corrinne Sande, Director for Computer Science Information and CyberWatch West, have been working diligently to expand CyberWatch West. The College is currently working on developing a regional cybersecurity training center which will position the College to submit a grant proposal in 2020 to become a national center.
- The College hosted the Mobile Consulate of Mexico on March 29 through March 31. The purpose of the Mobile Consulate of Mexico visit is to provide access to Mexican counterparts and community members for passports, IDs, birth certificates, etc. without having to travel to Seattle. It also provides a great opportunity for visitors to connect with the College's offerings and resources.

• **ctcLink** (4.1 Offer programs, services, and facilities that support college needs and market demands)

- A kick-off meeting was held with WCC's project implementation team on April 22 to clarify roles and expectations of the group as WCC moves forward with the initiation phase of the project.
- ctcLink work is on-track for a fall 2019 peer review of the initiation phase as the College moves towards the implementation phase in February 2020 and final "go-live" date of February 2021.
- **Finance** (4.1 Offer programs, services, and facilities that support college needs and market demands)
 - The State Auditor's Office (SAO) completed the financial statement audit.
 Formal results will be published by the end of April. The highest opinion was provided by the SAO while also noting one finding/deficiency in the area of inancial statement preparation.
- Facilities & Operations (4.1 Offer programs, services and facilities that support College needs and market demands)
 - The Learning Commons construction continues on schedule with excellent progress on interior framing and rough-in for electrical, mechanical and plumbing systems. The roof is complete and the weather barrier is nearly done. Exterior window frames are installed and window installation began with the third floor skylight system. Work will soon begin on the building exterior cladding which includes a combination of brick masonry and copper panels.
 - Student housing construction is running slightly ahead of schedule with the first through fourth floor framing and exterior sheathing complete. The majority of the membrane roof is installed and work continues on the metal roofing over the pod and community areas. The weather barrier installation is ongoing and will be followed by exterior window and door frame installations. Electrical, mechanical and plumbing rough-in is nearly complete with insulation and drywall scheduled to start by mid-May.
 - Design work is moving forward on the wetland mitigation associated with the student housing construction. In addition, the project will include the development of the new pedestrian path to replace the "goat trail" on the south side of Orca Lane as well as various sidewalk repairs across campus. This work is scheduled to begin in early August and be completed by the end of October 2019.
 - The Syre Auditorium skylight interior work is complete and efforts are focused on wrapping up the project following a two week schedule delay due to a long window lead-time. Window and copper siding will be installed the first full week of May with final completion on May 13.
 - **Conference & Event Services (CES)** (4.1 Offer programs, services, and facilities that support college
 - Agreements have been confirmed for facility use with the Bird Girl Industries Workshop, World Wide Dream Builders, Advance Care Planning, Impact WA Workshop, WA Satsang Society, the Roller Betties, Assessment & Treatment Association, Retirement Shield Workshop, Early Learning Meeting, Chuckanut Radio Hour and Whatcom Dollars for Scholars Awards Ceremony. Internally, CES is supporting the Global Culture Appreciation Night, Running Start Info Sessions, Business Club Student Night, Students Leading Change Conference, WCC

Preview Day, Healthcare Integration Workforce Summit, Fulbright Scholar Presentation, International Department End-of-Year Celebration, PTK Ceremony, Pride Club Drag Show and the Drama Production.

- **Bookstore** (4.1 Offer programs, services, and facilities that support college needs and market demands, 3.1 Ensure all students have access to campus resources that support educational success)
 - With the continued growth of Open Educational Resource (OER) material adoptions, the bookstore experienced a slight decline in course material sales for spring quarter. Compared with spring 2018 (S18), the math department alone has converted 22 formerly textbook-using sections to OER material sections. These OER materials are offered in the bookstore as an inexpensive (≈\$25) loose-leaf print format or are available as a free digital download for students. This use of OER material in lieu of traditional textbooks saved students \$23,000 in direct course material expenses (S19 vs. S18).
- **Technology** (4.1 Offer programs, services, and facilities that support college needs and market demands, 3.1 Ensure all students have access to campus resources that support educational success)
 - IT has been researching technology for the two major capital projects (Learning Commons and student housing), meeting with vendors, reviewing demonstrations, and looking at sample products to ensure they connect to the College's existing infrastructure and meets the College's stated needs.

 - Created educational marketing resources for students addressing sexual violence prevention in collaboration with Campus Safety and Security, and Human Resources.
 - Launched new Community Standards website, including customized resources for faculty, students, and community, and an overview of the conduct curriculum model.

Community Forum, the Opportunity Expo for Marysville School District, Students of Color Conference, Girls Go Tech, and visited Lummi Nation School. Over 260 students participated in these events.

- Facilitated Pod Prep Sessions for Ferndale, Lynden, Mount Baker, Nooksack, Burlington-Edison, and Blaine High School. Approximately 120 students attended these events.
- Hosted 130 Nooksack Middle School students on campus.
- **Student Success and Retention:** (Goal 1.1 Improve student success in retention, completion, transfer, and employment. 1.3 Provide students with mentors, internships, and career preparation, 3.3 Increase services focused on supporting marginalized student populations to close the equity gap in student outcomes)
 - Hosted two sessions of Wave New Student Orientation with 89 students participating (compared to 60 students in spring 2018).
- Access and Disabilities Services: (Goal 1.3 Promote student access through quality services and resources, 3.1 Ensure students have access to campus resources that support educational success, 3.3 Increase services focused on supporting marginalized student populations to close the equity gap in student outcomes)
 - Sent 468 letters of accommodation to faculty for spring classes.
 - Registered 441 students including prospective Summer and Fall 2019 students who have engaged with ADS staff through the application process and access planning.
 - At their spring meeting, the Washington Association of Post-secondary Education and Disability (WAPED), the professional development organization for Washington State colleges recognized Ward Naf and Kerri Holferty for the accessible information technology leadership they have provided throughout the state. Colleges and universities look to WCC as a model college for implementing and assessing best practices in accessible technology.

- Workforce Education: (4.1 Offer programs, services and facilities that support college needs and market demands)
 - The eleventh installment of Girls Go Tech was held on April 13. Eighteen middle school girls (down from 25 last year) enjoyed hands-on labs in CIS/cybersecurity, physics, and new for this year engineering, each led by WCC faculty and/or students. City of Bellingham IT Director and former CIS/cybersecurity program advisory committee member Marty Mulholland was the featured guest speaker.
- International Programs: (2.3 Strengthen partnerships with K-12 and higher education institutions, 2.5 Cultivate community awareness and support for the College.)
 - WCC International Programs will host Dr. Thuy Hoang, Fulbright scholar and business administration faculty from the University of Economics–Hue University, Vietnam, for speaking events at WCC and WWU on May 21 and 22. Dr. Hoang's research focuses on cultural tourism, sustainable tourism, human resource management, and tourism destination management and marketing. Her current research with the Fulbright Visiting Scholar program at Temple University focuses

on American tourists' experiences in Vietnam and their perceptions of Vietnam as a tourist destination. The Fulbright scholar program's Outreach Lecturing Fund (OLF) enables visiting scholars to share their research, speak about their home countries, and exchange ideas with U.S. students, faculty, and community organizations; as a result, colleges and universities are able to forge relationships with the visiting scholars and the Fulbright Scholar Program.

- Service Learning/Community Engagement (CE) Fellows: (2.5 Cultivate community awareness and support for the College, 4.5 Model leadership in environmental protection, economic viability, and social equity, the three pillars of sustainability)
 - The University of Puget Sound, in collaboration with WCC, WWU, and NWIC -Muckleshoot and Lummi Nation campuses, hosted *Learning Together in the South Sound*. Over 40 students, faculty, and community members gathered to advance opportunities for collaboration across multiple organizations in the South Sound to empower communities often lacking representation.
 - WCC and WWU CE Fellows, in partnership with Whatcom County Libraries,
- Cybersecurity grants: (4.2 Increase college enrollment and secure resources for the continued viability of the College.)
 - The National Visiting Committee (NVC) virtual annual review of the CyberWatch regional resource center in early April was very successful, resulting in an affirming report-out by the Committee on the accomplishments and future direction of the center. This is the last official NVC meeting for the regional center as CWW transitions to a national resource center, and ultimately to a national center by 2021.
- Area Health Education Center for Western Washington (AHECWW): (2.4 Foster learning, service, and leadership opportunities through community partnerships, 2.5 Cultivate community awareness and support for the College)
 - AHECWW participated in the University of Washington's Advancing Integrated Mental Health Solutions (AIMS) Center's *Inspiring Innovations Summit* meetings in Spokane and Seattle, presenting workforce innovations that integrate behavioral health and primary care, and focusing on increasing equity and access to healthcare careers through educational pathways development.
 - AHECWW has been supporting an online cohort of AHEC Scholars, including WCC nursing students, in an inter-professional certificate program since fall 2018. This certificate prepares students to work in team-based care in underserved communities and provides them with additional valuable experience for their resumes.
 - AHECWW co-hosted the Northwest Health Career Path Summit at WCC on April 26th. Summit objectives focused on recruitment of students from under-served, rural, and under-represented populations into health careers, to create a workforce that reflects the communities that our healthcare systems serve.
- **Nursing Program:** (1.2 Foster student learning through student-centered teaching and learning practices, 2.5 Cultivate community awareness and support for the College.)
 - The Whatcom nursing program participated in the Northwest Health Career Path Summit at WCC, and provided a session on *Applications of Healthcare Simulation Technology*. Participants learned about the use of simulation in healthcare education and participated in a simulated nursing activity.

Foundation and College Advancement – Sue Cole, Executive Director

- **Foundation** (2.5.2 Complete planning for capital fundraising campaign; 3.3.3 Ensure sustainability of Orca Food Pantry.)
 - Fundraising Update: Draft reports show that we received 17 gifts and pledges totaling \$46,576 for the month of April, a 78% increase over last April. Fiscal year to date as of April 26th, we have received \$1,132,159 in gifts and pledges, a 208% increase over last year's fundraising total.
 - Foundation News:
 - The Foundation Board of Directors have created two new quasi-endowments the General Scholarship Endowment and the Fund for Excellence Endowment. These two endowments will provide an ongoing source of income for the College; the Foundation will be able to count on annual distributions from these investments that will fund general scholarships and fund for excellence grants.
 - The Foundation has another new endowed scholarship supporting Whatcom students into perpetuity! The Michael and Linda Langey Endowed Scholarship is fully funded so it can begin earning for the next scholarship cycle. This new endowment will provide a scholarship to (1) a student enrolled in or accepted into the nursing program, or (2) to a student planning a career in teaching or (3) to a student involved in ASWCC student government. Mr. Langey has also committed a generous, six-figure planned gift that will grow the Michael and Linda Langey Endowed scholarship at the end of his life.
 - Alumni outreach efforts have begun and there is much good news to share. With the help of our colleagues in Institutional Research the Foundation sent a survey to 11,800 alumni – so far we have heard back from 8%, or 972 alumni! We are very pleased with this initial response and looking forward to getting to know our alumni, helping them stay connected with the College, and ultimately getting them reengaged. Developing and strengthening alumni relationships with the College is some of the most rewarding work we do and incredibly valuable to the College in the long term.
 - WCC Foundation Board Directors are out in the community and acting as ambassadors regularly. In May and June several of them will be attending high school scholarship events and presenting certificates to students who will be attending Whatcom Community College in the fall. Our board directors will be representing us at Meridian, Lynden, Mt. Baker, Nooksack Valley, Sehome, Ferndale and Blaine High Schools at events in May and June.
- **Community Affairs** (2.1.3 Present capital project (i.e. Learning Commons, student housing) updates to help foster ongoing mutual support with the local community; 2.5.1. Build and strengthen new and existing relationships with local businesses and community groups as college supporters to help fund initiatives and develop advocacy for the college.)
