◆ CALL TO ORDER Chair Rebecca Johnson officially called the Board of Trustees meeting to order at 2:00 p.m. Present in addition to the chair were trustees Wendy Bohlke, Steve Adelstein, John Pedlow and Teresa Taylor, constituting a quorum. Others present included President Hiyane-Brown; Nate Langstraat, Vice President for Administrative Services; Barry Robinson, Vice President for Instruction; Luca Lewis, Vice President for Student Services; Terri Thayer, Interim College Equity Officer; Kerena Higgins, Assistant Attorney General; and Rafeeka Kloke, Special Assistant to the President.

ACTION TO ACCEPT AGENDA

- → Trustee Taylor moved to accept the agenda. It was seconded by Trustee Pedlow and the **motion was** unanimously approved.
- Chair Johnson announced that there is a designated time for public comment on the agenda.

INTRODUCTION

- ★ Kerena Higgins, AAG introduced Drew Nishiyama and Julie Nichols, AAGs assigned to Whatcom Community College beginning July 1, 2022. Nishiyama will serve as the primary AAG for the College.
- → President Kathi asked Eric Davishahl, Engineering faculty, to introduce the WCC student team consisting of Emily Worthy, Babak Abedsaidi, Montana Williams, and Malachi Crump who won first place in the undergraduate student poster competition with their poster titled "aMAZEing Middle School STEM Outreach". The students presented their poster and shared their experiences with the project.

→ Proposed Submission of substantive change proposal to NWCCU to offer new BAS degree in social work

Trustee Bohlke moved to approve the submission of a substantive change proposal to NWCCU to offer new Bachelor of applied science in social work degree. It was seconded by Trustee Pedlow. The motion was unanimously passed.

→ Proposed 2022-23 S&A Budget – Carlyn Finerty, ASWCC President

Finerty shared a PowerPoint presentation with an overview of the proposed 2022-23 S&A Budget.

Trustee Taylor moved to approve the proposed 2022-23 S&A Budget as submitted. It was seconded by Trustee Pedlow. The motion was unanimously passed.

→ Proposed 2022-23 WCC Operating Budget – Nate Langstraat, Vice President for Administrative Services

Langstraat shared a PowerPoint presentation with an overview of the proposed 2022-23 WCC Operating Budget. He stressed the importance of continuing revenue generation and budget saving discussions throughout the academic year.

Trustee Adelstein moved to approve the proposed 2022-23 WCC Operating Budget as submitted. It was seconded by Trustee Pedlow. The motion was unanimously approved.

PRESIDENT'S REPORT

- → President Kathi shared that hearing stories about our students and their accomplishments at Honors and Awards ceremony was truly amazing. She was proud of the way faculty and staff had supported our students.
- → On May 18, 2022, WCC NCyTE and Anvil Corporation hosted a ribbon cutting ceremony for Cyber Range located at Anvil Corporation. It was well attended by industry, education and community partners along with local, state and federal elected officials. The event included a student demonstration. It is a great example of a partnership between education and industry.
- → Paul Francis has been hired as the Executive Director of State Board of Community and Technical Colleges. He is currently the Executive Director of Council of Presidents.
